

# Sr. High Summer Trip Covenant 2012

Please carefully read this covenant, if you understand and agree to what is written please sign and date both copies, returning one to the drop box and keeping one for yourself. A signed covenant is required for trip registration.

## Serving

- As a participant of the Sr. High Summer Trip 2012, I understand Calvary Lutheran Church is subsidizing part of the trip cost, and I therefore commit to **servicing** at three of these events (minimum):
  - Lenten Meals & Maundy Thursday Supper (Wednesdays, February 22-Thursday April 5, 2012)
  - Easter Breakfast (Set up Saturday, April 7, 2012 and breakfast Sunday, April 8, 2012)
  - Golden Valley Days Rummage Sale (Friday, May 18 and Saturday, May 19, 2012 and the two weeks preceding)

I understand I will not be paid as an individual, rather money made from these service and fundraising opportunities will go towards Calvary Lutheran Church subsidizing part of the trip cost for myself and others.

## Expectations & Consequences

- As a participant of the Sr. High Trip 2012, I understand I may be sent home by Sarah Burton or Bryan McInnis if I put another participant in danger, if I intentionally hurt another participant, if I bully another trip participant, if I pull unreasonable pranks, if I sneak out of the lodging at night (or am in general not where I'm supposed to be when I'm supposed to be there), if I use tobacco, drugs or alcohol or if I do anything else Bryan or Sarah feels jeopardize my trip or other participants. If I do get sent home, it is at my parents' expense.
- As a participant of the Sr. High Summer Trip 2012, I will leave my cell phone and other electronics at home so I can be fully engaged in everything God has in store for me. iPods may be used for travel and sleep only; if spotted elsewhere, adult leaders may confiscate them.
